To Whom It May Concern:

The purpose of this letter is to provide guidelines to organizations or parties interested in applying for outreach dollars from Relay Nevada. The primary focus for outreach dollars is two-fold.

A major part of the outreach effort targets educating the general public regarding Relay Nevada and related services, with much of the focus on using 7-1-1 and the "Don't hang up" campaign. Commercials have been developed for this purpose, and will be aired for 6 months out of the year, thus, allowing funding for local outreach efforts addressed in the next paragraph.

This brings us to the other equally important part of outreach, and that is the community based, grass roots, outreach. This outreach targets the local users of Relay Nevada and includes education on the use of Relay, Equipment distribution, Advocacy and new technologies related to the program.

The following is Relay Nevada's new guidelines for sponsorship. Relay Nevada has allocated a certain amount of dollars for sponsorship activities. In addition, each organization can receive up to two (2) sponsorships per year if funding is available.

Parties interested in applying for funds must first fill out the "Relay Nevada Sponsorship Application Form" and fax it or mail it to the Relay Nevada. This form can be requested from the website at [www.relaynevada.com](http://www.relaynevada.com). The application will be jointly reviewed by Sprint and ODS. A major consideration for each application will be the events impact to the community and the overall "return on investment" for Relay Nevada. Parties applying will be notified in writing or by e-mail whether the request will be granted or not.

If granted, the following will apply:

There will be a \$250.00 maximum grant for each event. Flyers and other relevant information regarding the event will be requested for Relay Nevada files.

OR

If an agency raises specific funds for their event, and can show proof of such fundraising, such as pictures flyers and a bank deposit or similar, Relay Nevada may award a match to fundraising up to \$800.00. This fundraising cannot be generated from another company, per se, but must be a community based fundraiser, such as a car wash/bake sale/raffle, or other. Please be specific in the application regarding fundraising efforts.

Upon any award, Relay Nevada/Sprint asks to be able to provide presentations, flyers and other information at your event.
